Govt. College Bharmour was established in 2005 vide Government Notification No. EDN-A Kha (16) dated 03.08.2005. The College offers undergraduate programmes, namely Bachelor of Arts (BA) and Bachelor of Commerce (B.Com.) in affiliation with HPU Shimla and SPU Mandi. B.Sc. (non-medical) has been started from this session 2024-25.
